You agree to execute any financing statements that Stonefly may request in order to protect Stonefly's security interest and hereby authorize Stonefly to execute and irrevocably appoint Stonefly as your attorney in fact for the execution of such financing statements and for the exercise of its remedies as a secured party.

On behalf of your business, you certify that all information provided in this Application is complete and accurate, and you authorize Stonefly to obtain information about you personally and your business from credit reporting agencies and other sources Stonefly deems appropriate in considering this Application and subsequently for purposes of updates, renewals, or extensions of credit granted as a result of this Application or in receiving or collecting the Account. Should customer default in any such payments, Stonefly shall have the right, without notice to Customer, to declare all invoice amounts due and payable. In the event that Stonefly should commence any action or actions, or otherwise seek to enforce this agreement against Customer or any Guarantor, customer agrees to pay reasonable attorney(s) fees, court costs and other expenses, incurred by Stonefly whether or not suit is filed. This agreement is not transferable or assignable without the prior written consent of Stonefly. Customer agrees that any change in liability for any debts incurred to Stonefly due to a change in customer's form of business, shall not be effective until Stonefly receives actual notice of the change by certified mail. You agree that your transactions with Stonefly shall be governed by and construed in accordance with the laws of the State of California, without giving effect to its conflicts of laws principals. You further agree that any lawsuits between Stonefly and yourselves shall be brought only in the state and federal courts of Alameda county of California or the venue of Stonefly's choosing. You hereby submit to the jurisdiction of such courts in any dispute with Stonefly and you waive any objections to venue being in such courts.
